Terms and Conditions of Entry for Manufacturing Skills Queensland Promotions

1. Introduction

- 1.1. These Terms and Conditions, along with the Schedule, constitute the complete rules governing this Promotion. Capitalised terms in these Terms and Conditions have the meanings assigned in the Schedule unless otherwise defined herein.
- 1.2. The Promoter is identified in the Schedule.
- 1.3. By submitting an entry, you acknowledge that you have read, understood, and agree to be bound by these Terms and Conditions.
- 1.4. Updates to these Terms and Conditions will be posted on the Promotion Website specified in the Schedule.

2. Eligibility

- 2.1. Participation is open only to those meeting the Eligibility Criteria specified in the Schedule.
- 2.2. The following persons are ineligible to enter:
 - a) Directors, officers, management, employees, and immediate family members of the Promoter;
 - b) Directors, officers, management, employees, and immediate family members of agencies associated with the Promotion;
 - c) Any other persons specified as ineligible in the Schedule.
- 2.3. "Immediate family members" includes spouses, de facto partners, parents, guardians, children, siblings, grandparents, grandchildren, and in-laws, whether by blood, marriage, adoption, or domestic partnership.

3. Entry Process

- 3.1. To participate, follow the Entry Method detailed in the Schedule.
- 3.2. Entries must be received during the Promotion Period. The Promoter accepts no responsibility for late, lost, incomplete, incorrectly submitted, delayed, illegible, corrupted, or misdirected entries.
- 3.3. Entries that contain offensive, inappropriate, or defamatory content will be deemed invalid. Entries that violate intellectual property rights or contain unauthorised third-party materials will also be deemed invalid.
- 3.4. The Promoter reserves the right to verify the validity of entries and entrants at any time and may disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions.

11. General Provisions

- 11.1.
